**Re: INDEPENDENT AUDIT REPORT for the Shire of Serpentine Jarrahdale:
Byford, West Mundijong, Mundijong Urban, and Community Infrastructure Developer
Contribution Plan**

Scope

We have audited the various financial statements being the Financial Position, Comprehensive Income, and Reserve Balance (Statements) for the funding of the Byford, West Mundijong, Mundijong Urban, and Community Infrastructure Developer Contribution Plan (DCP) cash reserves. The Byford DCP has been operating since January 2014, with the West Mundijong DCP being gazetted in February 2018 and the Community Infrastructure DCP in June 2021. The financial years 2013-14 through to 2022-23 have been audited for the Byford DCP. All four active DCPs had financial transactions within the 2023-24 financial year. The closing cash balances as at 30 June 2024 were as follows:

- Byford DCP - \$5,411,606
- West Mundijong DCP - \$739,191
- Mundijong Urban DCP - \$244,651
- Community Infrastructure DCP - \$4,980,703.

The Shire is responsible for the information contained in the Statements and has determined that the Statements meets the needs of the expenditure allocated in accordance with the Developer Contribution Plan requirements.

We have independently audited the Statements in order to express an opinion on them to the Shire. The Statements attached in the appendix have been prepared, pursuant to the DCPs, for the purpose of reporting revenue and expenditure for the year ending 30 June 2024 for Byford, West Mundijong, Mundijong Urban, and Community Infrastructure DCPs. We have been appointed in accordance with Section 9.3(16)(3) of the Shire's Town Planning Scheme ("TPS") No. 2 for the Byford, West Mundijong, Mundijong Urban, and Community Infrastructure DCPs.

We disclaim any assumption of responsibility for any reliance on this report or on the Statements to which it relates to any person other than the purpose for which it was prepared.

Our engagement was undertaken in accordance with the applicable Australian Auditing Standards and relevant procedures and were performed to determine if:

- the Byford, West Mundijong, Mundijong Urban, and Community Infrastructure DCP cash reserve balances are correct





- the expenditure allocated to the Byford, West Mundijong, Mundijong Urban, and Community Infrastructure DCP cash reserves are in accordance with the individual DCPs.

Conclusion

In our opinion the Statements are fairly presented, free of material errors and or omissions and are in accordance with the requirements of the individual DCPs. We have confirmed through sampling of supporting documentation for each period that:

- the Byford, West Mundijong, Mundijong Urban, and Community Infrastructure DCP cash reserve balances are correct
- the expenditure allocated to the Byford, West Mundijong, Mundijong Urban, and Community Infrastructure DCP cash reserves are in accordance with the individual DCPs.
