The Shire has an open Expression of Interest form on its website for food vendors, stallholders or suppliers to be involved in Shire-run events.

Submitting an Expression of Interest does not guarantee a business will be selected to trade at any particular event.

The Shire's Vendor Information Pack 2024/25 is provided at **attachment 1**, which outlines the Expression of Interest process. An extract of the Vendor Information Pack is provided below:

CONSIDERATIONS

The selection of vendors for each event is at the Shire's discretion and may reflect the target audience and themes for individual events.

Priority will be given to vendors based in the SJ municipality or surrounding municipalities, and based on the following criteria:

- Menu items (Food Vendors only)
- Local, fresh, and seasonal produce, and high-quality menu items
- Diverse menu catering for various dietary requirements and price points.
- Diverse menu representing a range of culinary cultures.
- Availability of healthy food and drink options
