#### 4.6 Risk Profile

#### Bushfire

2023 was the second hottest year and the seventh-driest year on record in the SWLD. The above median hot, dry, and windy conditions that prevailed across WA over the summer period will see much of the state enter autumn with below median moisture in the soil, surface fuels and live vegetation.

Over the previous nine months, the southern half of WA has experienced above median temperatures and severe rainfall deficiencies, and it is forecast that warmer and drier conditions will persist during autumn. These conditions will extend existing soil moisture deficiencies and increase the availability of woody vegetation fuels in the SWLD. Therefore, an associated increased risk of bushfire is expected in areas of forest, woodland and shrubland within the Swan Coastal Plain.

#### **Natural Hazards**

Southwest Western Australia is likely to see rainfall that is typical for the June to August period. This includes regions which have recently been quite dry.

There is also an increased chance of unusually warm minimum temperatures, with large areas of the country very likely (greater than 80% chance) to have unusually warm minimum temperatures.

#### 5.8 Department of Fire and Emergency Services

Paul Postma, District Officer South East, DFES, noted the following:

- The prescribed burning period has potentially closed due to the level of rainfall.
- Due to the potential tree mortality on the scarp, there is a low likelihood that any
  prescribed burning will occur this year due to the dry summer we have just had.
- Due to the tree mortality, there will be a higher than usual level of dry timber fuel in the coming fire season.
- We are expecting a warmer wetter winter which may result in ideal growing conditions and high fuel loadings for the coming fire season.

#### 5.10 State Emergency Services

Martin Seward, Unit Manager, discussed his units' responses to local storm damage in the area with 12 Requests for Assistance (RFA's) with the majority of RFA's due to flooding in the new estates.

There has been a significant number of responses due to poor workmanship on the new builds.

WOW Day was a great success, thank you to the Shire for combining this event with the Citizenship Ceremony.

#### Chief Bushfire Control Officer Report - May 2024

#### **Preface**

- Leigh Mulholland finished in the CESM/CBFCO on 26/4/24, promoted to District Officer in the Mid-West Gascoyne region.
- Callum MacNeill covered the role from 7/5/24 to 31/5/24, temporarily seconded from the Department of Justice.

- Siobhan Bishop has been substantively appointed to the CESM/CBFCO role following a competitive recruitment process and commences on 17/6/24.
- Current focus is on ensuring a well-managed transition between prohibited/restricted/open burning times, supporting brigade AGM and nomination processes, ensuring the training calendar is maximised to best use, and preparation for the Shire's emergency services volunteer awards night in June.

#### Prevention

- The unseasonal conditions resulted in the FES Commissioner extending the Prohibited Burning Time across a number of metropolitan LGA's. The Shire further extended the PBT through to 13 May. From there, some specific guidance has been issued to the Shire's Fire Control Officers placing restrictions on permit issuance, to ensure risk is mitigated. This included no running fire in bush, as a result very little burning has occurred to date with the exception of piles (limited by guidance to FCOs as well) and 1m3 garden refuse.
- The Restricted Burning Time has been extended for a 2-week period through to 14
  June. Notwithstanding the rainfall forecast for week commencing 27/5/24, it was
  determined this was the correct approach given KBDI particularly to the north of the
  Shire. Guidance to FCOs regarding permits in this period will be relaxed compared to
  the past month after the two forecast cold fronts have passed.
- A number of treatment activities are underway, including Nettleton Rd mulching, spraying at Manjedal Brook Reserve, various verge mulching works, over 70km of tracks inspected with maintenance schedules now in place, management of Webb Reserve (eventual burning/baling), and a joined-up approach with ARC for mitigation works through the Serpentine railway corridor.
- This year's fire break notice has been reviewed by the Emergency Services team with minor modifications made.
- The Shire's text messaging service continues to grow with approximately 2500 persons registered. It has been used to good effect recently with reinforcing to residents the requirement to check EmergencyWA and the Fire Danger Rating prior to any burning in the Restricted Burning Period
- The Bushfire Awareness Team met on 9 May and determined to give support/attend to a number of events, such as the Serpentine Community BBQ on 16 May and Farmers Market on 25 May, as a well as work towards holding various Burn Smart/Street Meet brigade events between June and October, as well as a larger Be Bushfire Ready event in October.
- An unfortunate delay in the Oakford Station project has been communicated to the brigade with an avenue forward determined and being prioritised.

#### **Preparedness**

- The Shire's 7 brigades currently have 234 volunteers registered with DFES.
- Version 3 of the SJ Fire Services training calendar was issued on 15/5/24, reflecting a number of courses that required cancellation due to lack of applicants.
- Planning will soon start for the pre-season Rural-Urban Interface exercise.

#### Response

As a result of the unseasonal conditions experienced since the last LEMC resulting in a long extension to the traditional high threat period (bushfire), a number of major incidents have continued to impact the area into the year. These include:

- 9/3/24, mulch fire Orton Rd OLDBURY 3<sup>rd</sup> event of major mulch fire at same address. Resource intensive.
- 23/4/24, 3<sup>rd</sup> alarm bushfire Yangedi Rd HOPELAND 11Ha, resource intensive incident due to acid sulphate soils.
- 10/5/24, 3<sup>rd</sup> alarm bushfire Hopkinson Rd HILBERT 12Ha, fire started in Gazetted Fire District on west of Hopkinson Road and ran into SJ with high potential to impact RUI/private properties requiring an Emergency Warning. SJ brigades provided support over a single shift to CFRS/DFES.
- Various incidents where SJ brigades have provided support to neighbouring LGs. Incident Attendance statistics from last LEMC's reporting period to 27/5/24 are below.
