4. Discussion Item Two

Advisory Group Representation Request

Plan Actions: 3.3

Presented by: Manager Community Activation and Coordinator Community Development

The Shire has received a request for representation on the Access and Inclusion Advisory Group from Leisa Hanson, who was a previous member of the Access and Inclusion Advisory Group and a current staff member at Byford Secondary College.

Leisa's request outlined that whilst she did miss the original EOI dates for representation on the Access and Inclusion Advisory Group for the current term, there is also significant benefit in having a role on the Group that acts as a conduit and point of liaison between between schools and the Advisory Group/Council. As a specified role, Leisa's experience was provided as follows:

- Previous representative of the AIAG.
- Responsible for students in both Mainstream and Education Support at Byford Secondary College, within a portfolio of Inclusion and Diversity.
- Member of the Byford Secondary College School Board representing the school executive.
- Assisted in the establishment and ongoing coordination of the Primary School Deputies network (8 local primary schools and the highschool), representing ideal opportunity to share information broadly through school networks.

In order to consider this request, an amendment to the Terms of Reference and representation would have to be presented to Council. By way of preliminary feedback from schools regarding a point of liaison between local schools and the Advisory Group, Officers have reached out to 13 local schools with the following feedback received to date:

- 10 supportive of the suggestion for a representative on the Advisory Group and supportive of Leisa Hanson.
- 1 not supportive, but as a result of not clearly understanding role of the Access and Inclusion Advisory Group and how the representative position would liase with the school (this would be further refined if the proposal progresses)
- 2 no response to date

In considering whether the proposal for a local school representative has merit, comment/feedback on Leisa's request is requested from the Access and Inclusion Advisory Group, prior to this being presented or considered by Council.

Questions were raised by the Group on whether the position should more broadly be advertised. Officers clarified that the intent of the position would not be as a "community representative" available for any community member to apply to. Rather it would act similar to the current "organisational representatives" for promotion through school networks only.

Whilst Officers have made preliminary enquiries to local schools as outlined above, additional consultation or advertising of the position may be suggested. However, to date, no schools have proposed an alternative representative.

6. General Business

Items from Members and Shire

Lisa Ingram - Updated the group on a brand-new, nature-themed playground and upgraded facilities at Serpentine Dam, thanks to a \$2.5 million upgrade by Watercorp, The upgrade includes new picnic tables, accessible toilet facilities, and additional parking near the popular Bistro By the Dam. The original design was presented to the previous Access and Inclusion Advsiory Group with many of their suggestions and feedback incorporated.

- Feedback provided that current url on Shire website does not direct to the correct location. To be followed up and rectified by Officers.
- Feedback also provided that the landing page lacks clear visuals and images that would help visitors (particularly those requiring Accessible features) to feel confident in the level of amenity and lay-out prior to arriving to site.

Further to the above point, images/social stories on the Shire's website for local playgrounds and park areas to indicate parking, facilities and any other accessibility features is currently lacking. Good examples include:
