### **Officer Comment**

In December 2021, Council endorsed the establishment of the Keirnan Park Stakeholder Reference Group (KPSRG). The KPSRG Terms of Reference are provided at **attachment 1**.

The purpose of the KPSRG is to provide the Shire with advice regarding the needs and priorities of the Serpentine Jarrahdale community in matters relating to the development of the Keirnan Park Recreation Precinct.

Since the establishment of the group, 4 meetings have been held with the KPSRG to finalise the project scope for Stage 1A as well as finalise the detailed design for the senior sized oval and single floor pavilion, which will be delivered as part of Stage 1A.

Shire Officers believe the KPSRG has been working successfully and has provided a forum for all stakeholders represented on the group to be informed and involved in the project so that the delivery of Stage 1A meets the needs and aspirations of proposed user groups, as well as the broader community.

This Notice of Motion will provide the opportunity for other community and sporting groups who wish to be involved in the Keirnan Park Recreation Precinct project the opportunity to submit an Expression of Interest to be represented on the KPSRG.
