Thank you for your email below.

Reserve 19895, comprises Lot 1343 on DP 91501 and Lot 279 on DP 202681, and is owned by the State of Western Australia with a management order to the Shire for the purpose of 'Municipal Depot Site'.

As the management body, the Shire has care, control, and management of the Reserve in accordance with the *Land Administration Act 1997*. Any consideration of the future of the Reserve will need to be determined by the Shire in the first instance. I note the landowner appears to be encroaching onto the land - is that right? Can the Shire please confirm the extent of the encroachment, proposal area, and the Shire's position?

The Shire will need to confirm whether whole reserve is surplus to requirements or if partial excision and amalgamation is proposed to address encroachment or liaise with the landowner to remove their encroachment.

A formal proposal can then be submitted to the Department for consideration via proposal@dplh.wa.gov.au. The proposal would be subject to the Department's standard due diligence process, ensuring that Crown land is optimised to its highest and best use to the benefit of the State of Western Australia. If the whole reserve is considered surplus to the Shire's requirements the Department's Land Divestment team may consider alternative options for the site, including potential for standalone sale to the open market, and other Government requirements to determine highest and best use, however any encroachments would need to be removed.

If disposal of the whole or part of the Reserve via a sale and amalgamation to the adjoining freehold landowner is supported following the Department's due diligence investigations and referrals process, the land would be considered for sale to the adjoining landowner at the current unimproved market value under section 87 of the LAA. The land would be sold by the Department will the valuation determined by Landgate's Valuation Services and subject to Director's approval. If supported, the landowner would need to accept any costs involved, including but not limited to the purchase price, document preparation, lodgement, any easement and service considerations and preparation of a deposited plan. Additionally, the Shire will need to confirm agreement to revoke its management order over the Reserve. The process can take several months or longer, noting it is subject to responses from our referrals.
