We the undersigned wish to express our most fervent objections to the proposed Amendment to Approved Abattoir to Allow Increased Production, PA22/936.

For years this business operated outside of its conditional approval and was eventually granted retrospective approval to slaughter animals onsite (after years of doing just that unlawfully). Council failed in its duty to ensure this business operated within the conditions of the approval it was granted and surrounding homes were forced to endure the consequences of that inaction.

Wind and weather conditions in our shire often bring unbearably foul odours from the direction of the abattoir. The vile stench of faeces from holding yards, rotting offal and blood particularly in summer can be sickening. Affected residents are often unable to open windows, dine and entertain outside or run their evaporative air conditioners.

As the consultation process has now been opened to more ratepayers, we wish it known that we do not support this abattoir's application to increase production, as they have proved incapable of controlling the odour problem they create with their current approved production limit, despite supposed systems being in place since the 2015 council approval, for this purpose.

The provisions of the health act 1911 require that impact from emissions e.g. odours should not unreasonably affect residential amenity. Sadly, council has failed to act to ensure this is not the case and we have indeed been negatively impacted. For many years our ability to enjoy our homes has been diminished and we do not wish this to continue or indeed become worse.

Ground water contamination from the business is a concern, as evidenced by the vast number of flies in the reserve adjacent to the property.

The odour coming from this location attracts predatory feral cats and foxes which are a concern for anyone who has pets or keeps poultry nearby. The wildlife in surrounding areas are easy targets for these predators.

We have concerns about the consequential increased traffic supporting this business, using the historical track through the Oscar Bruns Reserve off South Western Highway to access the premises. The alternative of livestock trucks being driven through residential streets to access the premises via Butcher Road would be unsafe and impractical.

We have little faith that this business and council's policing of the abattoir can or will in future make improvements that give us the air quality we deserve. As owners in a Rural A development area, this was a factor in choosing to live here in the first place.

With residential areas being approved close to this business and the owner's indication that they would perhaps seek in future to shrink the already in our opinion, inadequate buffer zone, we are justifiably concerned that our ability to enjoy our own spaces is being eroded and our property values with it. We feel that the current location is now wholly unsuited to this type of business. We do not seek to close this business down, but do not support any further expansion. An abattoir is not the kind of business that should be surrounded by residential housing. It may have been acceptable as a butchering facility for pet meat in the past, but certainly not as an abattoir in an expanding Rural A residential area.

From the original developer sales booklet for Claire Morris Estate Stage 1, this business was not disclosed, and you (The Council) have imposed on us a noxious facility and further allowed expansion of this business, despite receiving complaints about it for years.
